PROPOSED GOODS AND SERVICES TAX

Mr. Lyle Dean MacWilliam (Okanagan—Shuswap): Mr. Speaker, it is my pleasure to rise pursuant to Standing Order 36 to present to the House a petition opposing the government's proposed goods and services tax measures.

These petitions are literally flooding in to all members of the opposition. This particular petition from individuals in Maple Ridge and surrounding areas, and Pitt Meadows in the lower mainland. It asks that the government reject the current proposal for a goods and services tax. It also asks that the government reform the tax system so that there is an effective minimum tax on wealthy individuals and corporations, and to ensure that if and when there is a broad public consensus on the sales tax measure to replace the manufacturers' sales tax, this reform measure not be an opportunity for the government to impose a massive tax grab which is just what this proposed goods and services tax is.

It is also my pleasure to provide a similar petition also signed by a number of constituents in the Maple Ridge area again protesting the Draconian measures taken by the proposed goods and services tax.

Mr. Ron Fisher (Saskatoon—Dundurn): Mr. Speaker, it is my honour to stand on behalf of several Canadians and present this petition duly submitted under Standing Order 36. These petitioners humbly showeth that the goods and services tax is an unfair tax in that it does not regulate itself on the basis of a taxpayer's ability to pay. They also state that the taxation on reading materials, haircuts, diapers and so on is a regressive, unfair tax, and they humbly pray and call upon Parliament to reject the current proposal for a goods and services tax.

FAMILY VIOLENCE

Jean Corbeil (Minister of Labour): While one of the options under review is the formation of a federal workers' compensation board, I have instructed my departmental officials to pursue possible improvements to the current process which could achieve similar results and ensure greater harmony between the federal and provincial systems.
