5. Is it to the knowledge of the Government that a Member of Parliament has bought, or obtained from the contractors who are demolishing these workshops, a part of the woodwork in order to build stores upon his properties?

6. What price did this Member of Parliament pay to the Intercolonial Railway

for the transportation of these materials from Hadlow Cove to Lévis?
