REASON FOR FAILURE TO PROCEED WITH BILL C-56 OF LAST  
SESSION—MOTION UNDER S.O. 43

**AWARDS AND DECORATIONS**

SUGGESTED AWARD TO SIR WILLIAM STEPHENSON—MOTION  
UNDER S.O. 43

**Mr. Erik Nielsen (Yukon):** Mr. Speaker, I should like to propose a motion under Standing Order 43 and I urge all members opposite to listen before shouting "no". Its urgency is due to the ailing health of the individual who is some 83 years old and who is the subject of this motion. My motion concerns a most singular and outstanding Canadian, Sir William Stephenson, who has been honoured by almost every western nation in the world save his own country, Canada.

Because he sought anonymity, held no military rank and wore no uniform after 1918—he never publicly displayed the decorations and medals awarded to him—and because he holds the British Military Cross, the 1914-1915 Star, the General Service Medal, the World War I Victory Medal, the French Commander of the Legion of Honour—
