The arrivals from British North America during the past month have been 45 vessels, 48,007 tons, against 54 vessels, 57,005 tons during the corresponding month last year, the aggregate tonnage to this date from all places during the years 1894, 1895 and 1896 has been 241,451, 275,427 and 282,918 tons respectively.

The slight improvement reported in our last circular continues, although there is little appreciable advance in values to record. Imports generally have been on a free scale, and the deliveries have been fair, but stocks of all articles are ample.

New Brunswick and Nova Scotia spruce and pine deals. The import generally by steamer has been large, viz., 14,924 standards, against 15,565 standards same month last year; 45,000 deliveries have been fair, 10,283 standards, against 9,094 standards in August, 1894; the stock is quite ample, being 15,774 standards, against 14,245 standards same time last year; prices have continued steady throughout the month with a slightly improved tendency, but some moderate shipments are necessary to establish a further advance.
