In view of the importance of the work of the Special Joint Committee on Tax Reform and in view of the Prime Minister's clear and well stated concern about the question of conflict of interest, would the right hon. gentleman consider seeking an agreement between this house and the other place under which all the members of that special committee might be invited to declare their directorships and other financial interests which could come into conflict with any proposed changes in Canada's tax legislation?

> Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I should not like to determine what the other house may wish to do in putting members on this committee. I am sure the suggestion put forward by the hon. member will be conveyed to them in one way or another. After all, they all have interests as taxpayers in what happens in connection with tax reform; it might be difficult to eliminate all people with an interest in taxation.

> Mr. Knowles (Winnipeg North Centre): A supplementary question, Mr. Speaker. Perhaps the Prime Minister would look more closely at what I said, either now or when he gets Hansard. I referred to members from both houses on that committee. My suggestion is that there might be some guidelines in accordance with which members of the committee would be encouraged to declare their interests in advance. I recognize the point that the Prime Minister cannot compel members to do this, but I wonder whether a lead could not be given?

> Mr. Trudeau: I believe the whole question of the Senate and House of Commons Act is to be brought before a committee, and this aspect could then be dealt with generally. I realize, and I have said this earlier, that the whole question of conflict of interest as tackled by the present statute is not adequately dealt with in the light of modern practices, and I agree that the whole subject might be looked into. I hesitate to say it ought to be done specifically for the purpose of this committee; it seems to me we are thinking in terms of a general question relating to many committees.
