Coast Improvements.

A special letter from Washington, D. C., to the Portland Oregonian says that during the coming summer the lighthouse board will investigate the various lighthouse and fog signal sites recom mended for Alaskan waters by shipmasters and others. The appropriation of \$500,000 proposed for this purpose by Senator Foster was, cut to \$300,000 by the senate committee on commerce, aithough the treasury department favored the larger expenditure. There is, little likelihood of any appropriation being made during the present session of congress. There is a disposition in the house, where Corgressman Jones has been active in endeavoring to advance legislation of this kind, not to allow any sum to be expended for Alaska, The evening's epiertaliment to conclude with EDDIE DOLAN'S masterplece, lighthouses until next winter. The reasons given for this is that appropriations amounting to nearly \$700,000,000 have already been arranged for, and that

it is injudicious to allow any addi tional sum to be approved.

However, it is practically certain that an appropriation will be made during the second session of the 86th congress, both for the lighthouses and fog signals for Alaska, and also for a system of submarine cables for that district. A survey for the proposed cable, 'in accordance with Senator Foster's bill, will shortly be instituted. The desirability of the cable and lighthouses and fog signals is admitted quite generally.




