Schedule of Convictions by Her Majesty's Justices of the Peace within the United Counties of Huron and Bruce, From the July to the November Sessions 1853.

A BY-LAW

To authorize the Municipal Council of the United Counties of Huron and Bruce to borrow the sum of Two thousand Pounds on the credit of the Consolidated Municipal Loan Fund...

WHEREAS by an Act of the Provincial Parliament, intituled, 'An Act to establish a Consolidated Municipal Loan Fund, for the purpose of building a Court House and County Offices for the use of the United Counties of Huron and Bruce...

AND WHEREAS for the accommodation of the Courts, connected with the administration of Justice, it is necessary that a Court House and the necessary County Offices belonging to the same should be built...

And whereas it will require the sum of Two thousand Pounds to build and complete the said Court House and Offices, and it will require the sum one hundred and sixty pounds to be raised annually upon all the rateable real and personal property within the said United Counties...

Be it therefore enacted by the Municipal Council of the United Counties of Huron and Bruce, and it is hereby enacted by the authority of the same, That the Wardens of the said United Counties...
