#### CANADA GRAIN ACT

#### **RE-INTRODUCTION OF LEGISLATION**

## On the Orders of the Day:

Mr. M. LUCHKOVICH (Vegreville): I have received more than a dozen letters in the last week from farmers of the west asking me what the government is going to do in regard to the measures that were before the House last year, but which failed to become law owing to the dissolution of parliament. The farmers of the west are very anxious to know what is going to be done; they do not wish to see these measures go by the board, and they are afraid that some of these measures might not be re-introduced in this parliament at all. I have a letter here from P. B. Anderson, of Tofield, Alberta, dated March 8, 1927, and reading as follows:

Dear Sir:

At the untimely dissolution of the last Dominion parliament there were several important measures that went "in the wash". I am referring especially to the Agricultural Credits bill and to the amendments to the Grain Act. Those two measures, it seems to me, are of the greatest importance to us farmers of western Canada. We are therefore keenly and anxiously watching and waiting to know what will be done with them at this session of parliament.

Mr. SPEAKER: Order. The hon. member cannot by way of quoting from a letter state what he could not state verbally himself. He has put his question to the government, and he cannot go on to comment on the grievance.

Mr. LUCHKOVICH: I would like to ask the Minister of Trade and Commerce what is going to be done with the amendments to the Grain Act.

Hon. JAMES MALCOLM (Minister of Trade and Commerce): I can assure my hon. friend that the amendments to the Grain Act will be brought down in due course. I fully expected that they would have been brought down before this, but other legislation had to take precedence. They will be brought down following the report on the maritimes.

## SPECIAL WAR REVENUE ACT, 1915, AMENDMENT

The House resumed from March 15 consideration in committee of Bill No. 149, to amend the Special War Revenue Act, 1915— Hon. Mr. Robb—Mr. Johnston in the chair.

Sections 1 to 3 inclusive agreed to.

On section 4-Printers, etc., to be deemed producers or manufacturers.

Mr. BENNETT: I asked the minister the other day a question regarding the amount of business that had to be transacted before the section could apply. The matter is one of regulation?

Mr. ROBB: Yes.

Mr. BENNETT: I daresay that other members have received, as I have done, a circular letter from the Retail Trade Bureau of Canada dealing with this phase of the bill, and if the matter is one of regulation it is unnecessary to discuss it further than to ask the government to give it that attention which the memorandum warrants.

Mr. ROBB: The minister who administers the act has the matter under consideration, but it is not sufficiently advanced to justify a report upon it.

Section agreed to.

Section 5 to 9 inclusive agreed to.

On section 10-When paragraphs 3, 4, 5 and 6 of section 5 and section 6 come into force.

Mr. BENNETT: Why July 6?

Mr. ROBB: That is the date the returns come in for the previous quarter.

Mr. BENNETT: If you make it July 6 there will be several days in that month to which the old rates will apply and the returns will have to be made accordingly. The date should be changed. As it stands it rather complicates than simplifies matters.
