1. Is Lieut.-Colonel A. G. Wygard, supplementary reserve, one of the group of officers representing Canada on the united nations mission for India and Pakistan?

2. If so, is he a Canadian citizen, either by birth or naturalization?

3. If by naturalization, when did he apply for and receive Canadian citizenship?

4. What service did Lieut.-Colonel Wygard have in the Canadian army?

5. When was he placed on the supplementary reserve?

6. How long has Lieut.-Colonel Wygard resided in Canada?

7. Did he, at any time during world war I, serve in the armed forces of any country at war with Canada? If so, in the forces of what country, and what rank did he hold?

Mr. Blanchette:

1. Yes.

2. Yes, by naturalization.

3. Applied 29th July, 1943. Received certificate 28th February, naturalization 1944.

4. Appointed lieutenant August 1942, and employed with directorate of military intelligence. Wygard continued in intelligence work for the balance of the war, serving in Ottawa; Washington, U.S.A., and London, England. He was promoted to captain in May, 1943; to major in May, 1944, and to lieutenant colonel in August, 1945.

5. 4th March, 1947.

6. Since 12th July, 1940.

7. This department has no record of this officer having served in the armed forces of any country at war with Canada during world war I.

BELL TELEPHONE COMPANY-APPLICATIONS FOR RATE INCREASE

Mr. Fulton:

1. Does the dominion government telephone service base its rates for service in whole or in part on telephone rates charged by commercial telephone companies?

2. If not, on what basis are its rates assessed?

3. Is the dominion government opposing or otherwise the applications of the British Columbia Telephone Company, a Bell Telephone subsidiary, and the Bell Telephone Company for increases in telephone rates?

4. Is the dominion government or the Department of Transport to be represented in any way before the board of transport commissioners on the hearing of the above mentioned applications? If so, how is it to be represented?

Mr. Chevrier:

1. In part, yes. The monthly rental is lower than a commercial company would [Mr. Chevrier.]

3 and 4. No. Under section 52 of the Railway Act, any aggrieved party may appeal to the governor in council. It would be inappropriate for the government to be represented by counsel at the hearing of a case upon which it might later be called to sit in judgment.

It might be added that information in the department indicates that the British Columbia Telephone Company is not a subsidiary of the Bell Telephone Company of Canada.
