BRITISH NORTH AMERICA ACT

AMENDMENT RESPECTING APPOINTMENT OF JUDGES

Mr. Robert Stanbury (York-Scarborough) moved for leave to introduce Bill No. C-236, to amend the British North America Act, 1867 (appointment of judges).

Some hon. Members: Explain.

Mr. Stanbury: Mr. Speaker, I think all hon. members will agree that in Canada we have been most fortunate in the high quality of our judiciary and in the public confidence which it has earned. However, the Canadian Bar Association at its last annual meeting asked its executive to establish a committee on the judiciary to assist the government in carrying out its responsibilities in this regard, without interfering with its prerogative to appoint judges.

This bill proposes that the government, before making appointments, obtain the opinion of the legal profession as to the suitability and qualifications of persons being considered for appointment. In my submission this is
