

Questions

Bilateral air agreements between Canadian and European countries do not provide for landing rights at Toronto for their designated air carriers. BOAC exercises traffic rights at Toronto because the Canada-UK bilateral air agreement provides for such rights.

2. International flights of KLM, Lufthansa and Alitalia are not destined for Toronto (see reply to 1 above), and must terminate at Dorval. Such air carriers as are authorized to exercise traffic rights at Toronto are not required to land at Dorval.
