POSSIBLE MODIFICATION OF FISCAL ARRANGEMENTS WITH PROVINCES

Does the Right Honourable Prime Minister intend to amend the tax basis sharing arrangement during the present session or are these measures contemplated for the next session only?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the present arrangements will expire next spring. However, it is anticipated that new arrangements will be entered into between the provinces and the federal government before the expiration date. The government will report to the House in due course.

Mr. Valade: Mr. Speaker, I wish to ask a supplementary question.

I would like to ask the Prime Minister for further details. Is his answer to be construed as to mean that the provinces simply cannot hope that the tax basis sharing will be changed before 1972 or 1973?

Munro (Minister of National Health and Welfare): Mr. Speaker, there are technical discussions going on almost continuously between the department and the tobacco interests, but as far as the termination date is concerned we know nothing more than what the tobacco manufacturers themselves have said. They have publicly announced that, in terms of broadcasting, their termination date is the end of this year.

Mr. Mather: Is it not a fact that the meetings that are taking place are seeking to establish a target date for the termination of all cigarette advertising?

FEDERAL-PROVINCIAL CONFERENCE

ANNOUNCEMENT OF AGENDA FOR MEETING OF FIRST MINISTERS

Mr. Roch La Salle (Joliette): Mr. Speaker, I would like to direct a question to the Prime Minister.

Considering that the prime ministers are going to meet in a few days' time, I would like to ask the Prime Minister whether the program of that meeting has been decided upon, and whether it will be made public before the opening of the conference. Also, in view of the concern expressed by some provinces about implementation of the new tax system, will this issue be discussed with the prime ministers?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I followed the usual procedure of submitting to provincial premiers, two or three weeks ago, a draft program based on the issues that the provinces and ourselves feel should be discussed. Again according to established procedure, the first thing that the conference will do will be to agree to that program or amend it—and only then will the program be made public.

However, as I said earlier when I answered a question from a member of the Social Credit party, I think, and another one from the Progressive Conservative member for Sainte-Marie (Mr. Valade), it is the intention of the government to discuss the tax sharing arrangements if the provinces so wish.
