INCOME TAX—POSSIBLE ELIMINATION OF INDEXATION OF PERSONAL EXEMPTIONS—MOTION UNDER S.O. 43

Mr. Donald W. Munro (Esquimalt-Saanich): Madam Speaker, the urgent and pressing nature of my motion under Standing Order 43 arises because of the introduction tomorrow evening of the budget and, therefore, I hope it will have the unanimous consent of this House.
