company or a paper company took over a smaller paper company, they are unlike the most recent mergers, the large mergers we have seen by conglomerates. That is really not dealt with by this proposed Act at all.

For these reasons and many others we intend to oppose this Bill. I can assure Members of the House that we will have a substantial number of amendments when this Bill goes to committee.

Mr. Côté (Langelier), seconded by Mr. Hnatyshyn moves that Bill C-91, an Act to establish the Competition Tribunal and to amend the Combines Investigation Act and the Bank Act and other Acts in consequence thereof, be read the second time and referred to a legislative committee; and the amendment of Mr. McCurdy:

That the motion be amended by deleting all the words after the word "That" and substituting the following therefor:

Bill C-91, an Act to establish the Competition Tribunal and to amend the Combines Investigation Act and the Bank Act and other Acts in consequence thereof be not now read a second time but that it be read a second time this day six months hence.

The question will therefore be on the amendment.
