UNPRESCRIBED SHORT-STRAWED WHEAT VARIETIES

Question No. 323-Mr. Althouse:

- 1. Did the Minister of State (Canadian Wheat Board) set up a committee to examine the options for dealing with the unprescribed short-strawed wheat varieties and, if so (a) what criteria were used in the selection of the members (b) who are the members of the committee (c) what aspects of the industry are represented?
- 2. (a) Have any members of the committee grown the unprescribed varieties or sold them for seed purposes and, if so, which members (b) how many members have bought the production of such unprescribed varieties for use as feed or as an item of commerce?
- 3. Is the (a) importation (b) purchase for commercial use (c) sale of such unprescribed varieties legal?

Hon. Charles Mayer (Minister of State (Canadian Wheat Board)): 1. Yes, the committee was made up of representatives of producer organizations, grain handling companies, exporting firms, the Canadian Wheat Board and the Canadian Grain Commission. Present, with the Minister of State (Canadian Wheat Board), for the announcement of the Government's response to the committee's findings were the Chief Commissioner, Canadian Wheat Board; the Chief Commissioner, the Canadian Grain Commission; and the Chief Executive Officer, Manitoba Pool Elevators; and a representative of the Western Canadian Wheat Growers Association.

- 2. Whether or not a member of the committee had grown or purchased unprescribed wheat varieties was not a consideration for participation on the committee.
- 3. It is illegal under the Canada Grain Act to import unprescribed varieties into Canada. However, once unprescribed varieties are present in Canada, it is legal to grow and market them.
