PRESS REPORT INDICATING ATTEMPT TO EQUALIZE CASH FLOW-REQUEST FOR QUOTA STATEMENT

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, I ask the Minister of Agriculture whether he gave an interview to Mr. Hyman Solomon a while ago. Such an interview is reported as having taken place. Apparently this is a case of another Solomon come to judgment. Did the minister advise Mr. Solomon that there would be a fall-away this year in total farm cash income for all sales of wheat, oats and barley of \$450 million. Also, did he use these words which appear in quotation marks in the newspaper article:

What we will be trying to do is equalize as far as is possible the cash flow of farmers who are stuck with the kind of grain the market simply doesn't want at the moment with those who are lucky enough to have what the market wants.

Is this the plan of the government, or was it a midsummer night's dream on the part of the minister when he told Mr. Solomon this?

Mr. Speaker: Order, please. I am not sure whether the question is in proper form; in [Mr. Speaker.]

sure the hon. member did not intend to use fact, I have serious doubt about it. However, in view of the fact that the matter has already been raised by way of a question of privilege, the minister might be allowed to reply to the question.

> Mr. Diefenbaker: Did not the minister know when he made the statement to Mr. Solomon that further action was going to be taken, or was it a midsummer night's dream?

> Mr. A. P. Gleave (Saskatoon-Biggar): I have a supplementary question for the Minister of Industry, Trade and Commerce, Mr. Speaker. In view of the fact that by very rough division approximately one-third of the delivery points are on a quota of three bushels to the acre, one-third are on four bushels to the acre and one-third on five bushels, will the minister make a statement to the house prior to our adjourning for the summer recess setting out how the five-bushel quota objective of the Canadian Wheat Board is to be achieved? We would like to know what the plans and programs of the government are.
