Reported with amendments, 183. Committed; Reported; Passed, 189. By the Senate, with amendments, 257. Considered; Agreed to, 272. R. A., 439. (46 Vic, c. 49.)

FAURE ELECTRIC ACCUMULATOR COMPANY:—Petition for an Act of incorporation, 61. Report of Notice, 88.

2. Petition praying that the close season for fly-fishing for salmon may be made to correspond with the close season for net-fishing, 56, 77, 116, 124, 129, 171.
3. Petition praying that fishermen may be allowed to catch and use for bait, as heretofore, the small fish called the minnow, 77.
4. House in Committee to make better provision for the issue of Fishery Leases and Licenses, and with respect to the use of nets and other apparatus for the capture of salmon, &c. Resolution reported; Bill presented, 196. See *infra*, 5.
5. Bill further to amend "The Fisheries Act" (Mr. McLelan); Ordered; Presented, 196. Read second time, 271. Committed; Amended; Considered; Passed, 363. By the Senate, with amendments, 407. Considered; First amendment disagreed to for a certain reason; Subsequent amendments agreed to; Message to the Senate, 429. Senate insists upon its first amendment, for certain reasons, 436.
6. Bill to extend to British Columbia the Act relating to fishing by Foreign vessels (Mr. Bowell); Ordered; Presented; Read second and third time and passed, 413. By the Senate, 436. R. A., 441. (46 Vic, c. 27.)
