CONDITIONS OF CONTRACTS WITH LOCAL AUTHORITIES.

ENGLAND AND WALES.

THE following information is extracted from a Parliamentary Return (No. 47 of 1898). The Return relatesto urban districts only, which are classified under three heads—viz., County Boroughs, Non-county Boroughs, and Other Urban Districts; County Councils and the governing bodies in London are not included:—

CONDITIONS AS TO WAGES.

These vary very much in different localities, and may be classified under the following main heads:—
(1) current rates, (2) rates recognized by trade unions, (3) rates agreed on by associations of employers and employed, (4) rates fixed in contract. The conditions included in each of these classes are not absolutely identical. Some authorities require the wages paid to be those in force within their own-jurisdiction; others, again, specify that they shall be those in the district where the work is executed. In some cases the stipulation applies merely to the contract itself; in other cases it is required that the contractors' workmen generally shall be treated on the same footing.

CURRENT RATES.—These are required to be paid in the case of contracts with each of the following thirty-one county boroughs:—
