He is a highly competent civil servant who has been appointed to this position. I think this is no time to be casting slurs on a person who has been appointed to this position.

Mr. Speaker: I did not hear any point of order. The minister was replying to the question which the hon. member raised. I think a further supplementary question would be inadvisable.
