## CORRESPONDENCE RESPECTING AMENDMENT OF CONSTITUTION

#### Motion No. 13-Mr. Brewin:

That an humble Address be presented to His Excellency praying that he will cause to be laid before this House a copy of all correspondence exchanged during the past year between the Minister of Justice and the Attorneys General or other provincial ministers regarding methods of amending the Constitution of Canada; and also for other papers and documents prepared for and presented to the meeting held in October between the Minister of Justice and the Attorneys General relating to the amendment of the Constitution of Canada.

Hon. Guy Favreau (Minister of Justice): Mr. Speaker, the Government will agree to the first part of motion No. 13, which relates to all correspondence exchanged during the past year between the Minister of Justice and the Attorneys General or other provincial ministers regarding methods of amending the constitution of Canada.

As to the documents referred to in the remainder of the motion, if it is agreeable to the House I suggest that no order to produce them be made, because they are in the nature of confidential documents. These documents concern the in camera proceedings and discussions that took place between the Minister of Justice and the Attorneys General of the provinces. If it is agreeable to the mover I suggest that the motion be adopted in that fashion.

#### U.S. SUGGESTION RESPECTING PEACE FORCE FOR WESTERN HEMISPHERE

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I direct the Prime Minister's attention to the report of a suggestion made by Mr. George Ball, United States Under Secretary of State, on the creation of a force which I think he described as an inter-American peace force, to be maintained permanently for crises in the western hemisphere. What is the attitude of the Canadian Government to the creation of such a force limited to the Americas? Would the creation of such a force have a detrimental effect on United Nations peace keeping operations; and generally, has there been any action taken in the last few days on the part of Canada in the Western Hemisphere for membership, either direct or associate, in the Organization of American States?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, in so far as the first part of the question is concerned I, like my right hon. friend, noted with interest the proposal, perhaps an important proposal. We are taking steps to find out more about it through discussions with the United States Government authorities. I can only say now, pending further discussions, that we would prefer peace keeping forces of this kind to be under the United Nations rather than under any regional organization, though there may be occasions when regional organizations could
