INCREASE IN GOVERNMENT ADVERTISING

Right Hon. Joe Clark (Leader of the Opposition): Madam Speaker, it is perhaps not surprising that a Prime Minister who shows no concern about Canadians facing bankruptcy, Canadians facing loss of jobs, Canadians forced to leave their homes, that he, the millionaire from Outremont, sits there and smiles while Canadians lose their homes.

If we have a crisis in this country it is that Canadians do not well enough understand the role of their national government, and all that people on that side of the House want to do is tear it apart.

HOUSING

QUERY RESPECTING AHOP PROGRAM

Mr. Doug Lewis (Simcoe North): Madam Speaker, in the absence of the minister responsible for housing I wish to direct my question to the Prime Minister. Yesterday the government of Nova Scotia moved to assist AHOP home owners suffering under the double burden of more stringent income criteria and high mortgage interest rates, and among other things fixed the mortgage interest rate of 14 per cent. The Nova Scotia housing minister stated that he made two special trips to Ottawa to seek federal government help, but was refused. Since the federal government created the AHOP program, why is it bailing out of its responsibility at this time?

I will refer him to the hon. member for St. John's West who is always complaining that we should be keeping the deficit down and be spending less money. ASSISTANCE TO LANDLORDS

Mr. Doug Lewis (Simcoe North): The government recently moved to assist apartment owners who participated in the assisted rental program by increasing the maximum subsidy per unit from \$120 a month to \$180 a month. The reason given for the increase was that landlords are faced with an increase of 6 per cent or 7 per cent in mortgage interest rates. Why is the government moving to help landlords faced with bankruptcy, and refusing to help home owners faced with the same problem?
