REFUGEES

CHILEANS IN ARGENTINA—REQUEST FOR RE-EVALUATION OF FILES

Mr. Sergio Marchi (York West): Mr. Speaker, my question is for the Prime Minister. Last August in reference to the plight of refugees and immigrants he said to the country: "If we err, we will err on the side of compassion and justice". Since those words, the Government has turned back the clock on our immigration program and forced groups and churches across the country to mobilize against its unjust direction which is epitomized by the Government's irresponsible refusal to re-evaluate the files of the 70 Chilean refugees stranded in Argentina.

Given the new evidence presented on torture by lawyer Noel St. Pierre and the scenes on our TV sets during the papal visit to Chile, will the Prime Minister not order his Minister of Immigration to re-evaluate at least the 70 files and thus show Canadians that his policy on immigration is just, is compassionate, and is humane?

# [Translation]

Hon. Benoît Bouchard (Minister of Employment and Immigration): Mr. Speaker, the Government of Canada showed compassion in several ways and in various circumstances in a number of cases which were found deserving. However, we have always maintained that there is legislation in this country dealing with refugees which we intend to enforce. As I told my hon, friend yesterday, all the cases of Chileans now in Argentina have been assessed with special consideration to those referred to us as refugees. As for the others, I say again today, as I said and repeated yesterday, there is absolutely no question of reviewing the decisions.

## REFUGEES-MINISTER'S POSITION

Mr. Sergio Marchi (York West): It is not true, Mr. Speaker. The Minister of State for Immigration indicated to the House that on the basis of new information, the files could be reopened. My question to the Minister, therefore, is this: Why does he refuse to recognize the seriousness of the new evidence of torture? Why will he not even meet lawyer Noël St-Pierre? When will he start protecting the legitimate interests of his Department's clients? Or would the Minister rather stand on his statement that immigration is bothersome?
