**Hon. Bernard Valcourt (Minister of Fisheries and Oceans):** 1. The Department operates on a fiscal year basis (April to March 31) and data is available on this basis only. Attached are the projected capital expenditures by constituency in Newfoundland for the fiscal year 1989/90.

2. The Small Craft Harbours Capital Works Program for 1990/91 has not been finalized to date. It is anticipated that it will be several months before a final decision can be made on budget allocation and project selection, because assessment of winter damage has not been completed.
