Gardiner (Prince George-Bulkley Valley): Mr. Speaker, it is indeed a pleasure to have an opportunity to speak at report stage to a couple of amendments to Bill C-84, the legislation introduced, as a previous speaker said, by the dinosaurs on the other side of this House, these right-wing zealots, these extremists across the way, who are doing their best to remake and destroy this country as we have come to know it. The list has been repeated on a couple of occasions in the last few days. Yesterday the CBC. Before that, VIA Rail and Canada Post, particularly in rural areas. I think what this government is trying to do is remake this country so we will never recognize it again and for that all Canadians, all taxpayers, are going to pay.

We have to take a look at what I think are three very reasonable amendments to this legislation to privatize Petro-Canada, three very reasonable recommendations. The first one is an amendment saying that the chairperson and members of the board of directors of Petro-Canada must be Canadian residents. What is the big deal?
