THE COMMITTEE ON STANDING ORDERS.

FIRST REPORT ADOPTED.

Hon. Mr. YOUNG from the Committee on Standing Orders presented their first report. He said: I move that this report be now received.

Hon. Mr. FERGUSON—We have now the reports of the organization of all the standing committees of the House except the joint committees. I have no observation to make further than to congratulate hon. members of this House from Quebec and from Manitoba on the somewhat fair distribution of the chairmanships of the various committees that they have made between themselves, to the exclusion of all the other provinces.

Hon. Mr. LANDRY—Before the report is adopted, I should like to know if there was a quorum at the meeting of the Standing Orders Committee?

Hon. Mr. YOUNG-Supposed to be.

Hon. Mr. LANDRY—I want to know, as a matter of fact, if there was really a quorum of that committee? Is the hon. gentleman from Killarney chairman of that committee? Is the report signed by the chairman?

THE CLERK OF THE HOUSE-Yes.

Hon. Mr. LANDRY—I should like to know on what authority? Could the hon. gentleman give us an explanation?

Hon. Mr. YOUNG—I will leave that to the other members, who are present, to speak for themselves.

Hon. Mr. LANDRY—That is not giving an answer. This House should know if that committee sat this morning—if there was a regular meeting of the committee.

Hon. Mr. YOUNG—No, they adjourned until two o'clock for want of a quorum. They did not sit this morning.
