### OXFAM—PROPOSED STUDY OF FUNDING

I have not seen that particular quote, but I will look into it and take the necessary steps to have it examined.

Hon. A. C. Abbott (Minister of State (Small Business)): Mr. Speaker, as the hon. member is aware, in September I announced a policy which had been arrived at by my predecessor in a ten-point program. Some of this policy involves the burden of paper work, and in following legislation that we have introduced amendments to the CALURA legislation which have been given first reading. I hope to make further improvements in that area, apart from that legislation when it is passed. There are a number of other areas we are developing, including the purchasing policy of the government and its approach on venture capital, but a number of these things are going to take time, and I hope that when we do bring something before the House it will meet the hon. member's concerns.
