

Bathurst, Harriet, dau. of John McKenna, Esq. A merchant. Served in the Vol. Militia Force for a number of years, and retired with the rank of Captain, in 1874. Sat for present seat in Leg. Assem., N. B., from 1874 to 1878. First returned to the Commons at g. e. 1882 and re-elected at g. e. 1887 and 1891. A Liberal-Conservative.—*Bathurst, A. B.*

CAMERON, HUGH, M.D., J.P. (*Inverness.*)

Family came from Fort William, Inverness-shire, Scot. B. in the Co. of Antigonish, N.S., 18 March, 1836. M., Nov. 1865, Eunice, fifth dau. of Hon. John McKinnon, M.L.C., Antigonish. Graduated M.D. at Univ. of Philadelphia, March, 1861, and at the School of Practical Obstetrics, same city, Aug., 1861. Represented Inverness in the Commons from g. e., 1867, until 1872. Sat in the L.C., N.S., from March, 1879 to May, 1882, when he resigned. Re-elected to the Commons at g. e., 1882, 1887, and again at last g. e. A Liberal Conservative.—*Mabou, N.S.*

CAMERON, MALCOLM COLIN, Q.C. (*West Huron.*)

B. in Perth, Co. Lanark, Ont., 12 April 1832. Ed. at Knox Coll. Toronto. M., May 1855, Jessie H. dau. of Dr. John McLean, formerly in the Royal Navy. Called to the Bar U. C. 1860. Appt. l. Q. C. by the Ont. Govt. 11 March 1876. Was a Town Councillor, Reeve and Mayor of Goderich for several years. Sat for South Huron in the Commons from g. e. 1867 to g. e. 1882 when elected for West Huron. An unsuccessful candidate at g. e. 1887. Re-elected at last g. e. A Liberal.—*The Maples, Goderich, Ont.*

CAMPBELL, ARCHIBALD. (*Kent, Ont.*)

S. of the late Neil Campbell, who came from Argyle-shire, Scot., about 1812, settled in New York State, and removed with his family in 1830 to the Tp. of Howard, Co. of Kent. B. in the Tp. of Howard, 27 April, 1846. Ed. at the Common and High Schs. of the Co. M., 8 Feb., 1871, Miss Burk, of Colona, California. Is a merchant miller. Has been a mem. of the Town Council of Chatham for several years, Deputy Reeve of Chatham, in the Co. Council, and Chairman of the Finance Committee. First returned to Parlt. at last g. e. Unseated in Nov., 1887, but re-elected 2nd May, 1888. Re-elected
