

Ordered, That the Bill from the Legislative Council, intituled, "An Act to incorporate the Ursuline Academy of *Chatham*," be now read the first time.

The Bill was accordingly read the first time; and ordered to be read a second time, on Monday next.

Mr. *Mackenzie*, from the Joint Committee of both Houses on the subject of the Printing of the Legislature, presented to the House the Fourth Report of the said Committee, which was read, as followeth:—

The Committee have carefully examined the Document referred to in the following Motion for Printing, viz.:—

By Mr. *Mackenzie*,—Return to Address,—Plans and description of Lands (if any), Leased or Sold, or agreed to be Leased or Sold to the *Hudson's Bay* Company, or the Agent on the North Shore of Lakes *Huron* and *Superior*, with copies of Orders in Council and Correspondence, &c. The Committee recommend that certain portions only of the above Document be printed, and without the plans accompanying.

The Committee also recommend that the following Documents be printed, viz.:—

Return to Address,—Reports and other Documents made by the Indian Department in relation to the *Grand River* Navigation Company, while under control of the Corporation of the Town of *Brantford*.

Return to Address,—Papers having reference to the Sea Fisheries of the River and Gulf of *St. Lawrence*.

Supplementary Return,—Respecting Sea Fisheries of the River and Gulf of *St. Lawrence*.

Return to Address,—Correspondence relative to the Union of the North American Provinces.

Return to Address,—Statements of Expenses of Militia Force and Police Force sent to the Frontier.

Return to Address,—Statement of appointments in the Public Service of the Province since 1st July, 1864. (The appointment of Postmasters paid solely by commission, not to be printed.)

The Committee also recommend that the following Documents be printed in the Sessional Papers only, viz.:—

Report of Commissioners from *British North America* appointed to inquire into the trade of the *West Indies*, *Mexico* and *Brazil* (without the accompanying Maps.)

Return to Address,—Certain information respecting Law Stamps.

Annual Statement of the Jesuits' Estates.

Return from the *Hamilton* Industrial School.

Accounts of the *Quebec* Trinity House and Decayed Pilot Fund.

The Committee also recommend that the following Documents be not printed, viz.:—

Return to Address,—Respecting leaves of absence granted to Judges of *Lower Canada* during the last three years and relative to the holding of Courts.

Return to Address,—Showing the number of prisoners incarcerated in the Jail of *Niagara*, &c., from 1861 to 1865, the number under Medical treatment, and the number who have died; also correspondence between the Architect and Board of Prison Inspectors.

Return to Address,—Respecting Limits, Crown Lands, granted to late *Thomas Alexander Lambert*, in his lifetime of *Becancour*.

Return to Address,—Returns of all Clergy and Crown Lands unsold in the Townships of *Finch*, *Roxborough*, *Cambridge*, *Russell*, *Cumberland*, and *Clarence*.

Return to Address,—Names of persons tendering for repairs to *Port Dover* Harbour, &c.

Return to Address,—Correspondence with Department of Public Works in reference to *Hamilton* and *Port Dover* Road.

Proclamation declaring the Act, intituled, "An Act respecting the preservation of the "Public Health" to be in force.

Papers in the case of *Domina Regina*, versus *J. B. Daoust*.

Rules made by the Courts of Queen's Bench and Common Pleas for *Upper Canada*.
