Are the sergeants' and/or officers' messes at any or all of the Canadian Army locations at which the organization operates, required to purchase their supplies from the organization, and is the current price for beer, soft drinks, coffee and doughnuts at the establishment of the organization at camp Gagetown in excess of the current price for such articles at the officers' and/or sergeants' messes at such camp and, if so, why?
