Mr. Blenkarn: Madam Speaker, my supplementary question is, of course, directed to the Minister of Finance. The "if" involved makes it interesting.

The Minister of Finance has said that he has a study on capital gains. Would he refer that study to the Standing Committee on Finance, Trade and Economic Affairs? Will he allow the President of the Treasury Board, who wrote a book on "Fiscalamity", the disaster of capital gains, how it was hurting business, causing inflation, and so on—

Some hon. Members: Question.

Mr. Blenkarn: —to appear before that committee?

Mr. Hees: With his book under his arm.

Hon. Allan J. MacEachen (Deputy Prime Minister and Minister of Finance): Madam Speaker, I can remove the "if" from the hon. member's question and advise him that there is a study under way on the subject of capital gains. As I recollect, it was begun by my predecessor and was, therefore, well-launched. When it is completed, I will consider whether to send it to the committee. It sounds like a good idea.

COST OF RELOCATING DVA OFFICES IN CHARLOTTETOWN

DEFERRAL OF MOVE TO PETERBOROUGH

MR. DOMM—RELOCATION OF PARKS CANADA OFFICE— STATEMENT MADE BY PARLIAMENTARY SECRETARY IN ADJOURNMENT DEBATE

Mr. Bill Domm (Peterborough): Madam Speaker, I wish to raise a question of privilege respecting statements made last night in the House by the Parliamentary Secretary to the Minister of State for Science and Technology and Minister of the Environment (Mr. Simmons). The hon. member made a specific assertion about a statement I made on August 3, 1979, which is completely untrue in its description of that statement, and anyone in the House will verify that.

I should like to read the statement, and it was referred to just a moment ago by an hon. member on this side of the House. Last night in the House of Commons during the late show the parliamentary secretary to the minister stated:

-I am aware-

He was referring to myself.

Madam Speaker: Order, please. I think we will require a bit more silence in the House so we can hear what the hon. member has to say.

Mr. Domm: I can understand, Madam Speaker, why they prefer not to listen.

The parliamentary secretary to the minister stated:

-it was the administration of which he was a part-

He was referring to myself.

-which deferred the move for ten whole months-
