Order Paper Questions

2. Is it government policy to impose commitments on foreign companies seeking to invest in Canada before applications will be approved by the agency?

Hon. Herb Gray (Minister of Industry, Trade and Commerce and Minister of Regional Economic Expansion): In so far as the Foreign Investment Review Agency is concerned:

1. The Foreign Investment Review Agency does not approve or disapprove applications under the Foreign Investment Review Act. This is a function of the governor in council. A third application by Gannett Co. Inc. to acquire Mediacom Industries Inc., Mediacom Inc. and C.D. Maintenance Services Ltd. was allowed on October 30, 1981. Two previous proposals had been disallowed. Among the various improvements and additional undertakings submitted in the third, successful, application by Gannett was a commitment to purchase from Canadian suppliers for a period of three years the bulk of the newsprint required by a new U.S. national newspaper, assuming that its development proves feasible and successful. This, as is the case with all of the other undertakings, was offered by Gannett in support of its proposal. They were, in turn, accepted by the government as a condition of allowance.

2. It is government policy to allow all applications which offer significant benefit to Canada according to the factors set out in Subsection 2(2) of the Foreign Investment Review Act. Prior to an assessment of whether or not their proposals offer significant benefit to Canada, foreign investors are asked to identify any plans they may have with respect to employment, resource processing, sourcing, exports, Canadian participation, productivity, industrial efficiency, technological development, product innovation, product variety and any other relevant matters. However, it is entirely up to foreign investors to choose their own means to demonstrate that their proposals will be of significant benefit to Canada. In this regard, foreign investors frequently offer undertakings in support of their proposals. The undertakings, in turn, are accepted by the government as a condition of allowance.

2. The contract is based on tendered hourly rates for actual hours of work plus a fixed tendered amount for other expenses associated with fringe benefits, overtime and travel, etc.

3. The contract was awarded to Quebecair from June, 1977 to June, 1980. TB 771922 gave authority to amend the contract with Quebecair for a two-year period, plus an optional one-year period. Depending on whether both parties agree to extend the contract for the option year, public tenders may be called in May, 1982, or May, 1983.
