# CANADA-UNITED STATES TRADE AGREEMENT—POSITION OF PRIME MINISTER

CANADA-FRANCE DISPUTE—ST. PIERRE AND MIQUELON— REPORTED DEVELOPMENT OF FRENCH NAVAL VESSELS

**Mr. Brian Tobin (Humber—Port au Port—St. Barbe):** Mr. Speaker, my question is for the Deputy Prime Minister. The news service *Agence France Presse* has reported that France has decided for the first time in history to deploy full-time French naval vessels on patrol off the Islands of St. Pierre and Miquelon to "establish a military presence in French waters".

According to the report the French naval vessel *La Centaure* will be the first to patrol the waters off St. Pierre and Miquelon from December 3 to January 13. This vessel will be followed by additional vessels of the French navy after it returns to France.
