**Mr. Andre:**—when one has Canada's most recent—

**Mr. Prud'homme:** On a point of order, Mr. Speaker.

**Mr. Deputy Speaker:** Order, please. On a point of order, the Hon. Member for Saint-Dennis (Mr. Prud'homme).

**Mr. Prud'homme:** Mr. Speaker, I am not sure whether this is an *appel au règlement* or a question of privilege.

The Hon. Minister has spoken of a unanimous resolution having been passed by two separate Governments of the Province of Quebec calling for these amendments. Many years ago, we had a provincial Government asking that the federal Government not implement the old age pension program—

**Mr. Deputy Speaker:** That is not a point of order.

**An Hon. Member:** Not only is it not a point of order, one cannot tell what he is talking about.

**Mr. Deputy Speaker:** The Hon. Minister of Consumer and Corporate Affairs.

**Mr. Andre:** Mr. Speaker, I was merely reflecting on the fact—

**Mr. Henderson:** On a point of order, Mr. Speaker.

**Mr. Deputy Speaker:** I regret that I have to interrupt the Hon. Minister again. The Hon. Member for Egmont (Mr. Henderson) on a point of order.

**Mr. Henderson:** Mr. Speaker, the Minister made the point that two provincial legislatures unanimously passed a resolution supporting this Bill. I want to point out to the Minister that the Prince Edward Island Legislature also passed a resolution, and also unanimously, calling on the Government not to—

**Mr. Deputy Speaker:** Order, please. On debate, the Hon. Minister.

**Mr. Andre:** I just want to point out, Mr. Speaker, that I did not interrupt opposition Members when they were speaking—

**Mr. Gray (Windsor West):** Mr. Speaker, I rise on a point of order. I thought I just heard the Hon. Minister use words to the effect that he was going to let opposition Members get on with their demagoguery.

I respectfully direct Your Honour to Citation 320 at pages 105 and 106 of Beauchesne's Fifth Edition. Subclause (2) reads:

And at page 106 Your Honour will see the word "demagogue", which apparently was ruled unparliamentary on June 16, 1963, as reported at page 10194 of *Debates*.

Therefore I ask Your Honour to ask the Hon. Minister to withdraw his clearly unparliamentary remark.

I just want to point out—

**Mr. Tobin:** Mr. Speaker, on that point of order, I was the recipient, in my own humble way of reflecting the views of Newfoundlanders, of the Minister's statement in which he said that the Hon. Member was giving a new definition to the term "demagoguery", and the "blues" will show that.

On behalf of my constituents, whose humble voices I was merely reflecting and echoing off these ungodly walls—

**Some Hon. Members:** Order!

**Mr. Tobin:**—I ask the Minister to withdraw that insult to my constituents.

**Mr. Deputy Speaker:** The Minister has already spoken, and I consider the incident closed. Will the Minister continue, please.
