The minister must ensure that conditions exist that would allow the panel to conduct its inquiry. It is obvious that those conditions do not exist. That is why the panel resigned, because they could not proceed under the current conditions.

Therefore we maintain that the original court order is still in effect that now demands that the minister revoke that licence. Every day that passes when the minister does not revoke that licence, this federal government and the Minister of the Environment are in contravention of the court order. That surely is unacceptable, particularly from our own federal government.

There are some lessons to be learned in all this. First of all the big lesson is you do not mix the environment and politics the way this federal government and the Government of Saskatchewan have attempted to do it. There are all sorts of suggestions of deal making right from the beginning. The first licence was really part of a deal between the province of Saskatchewan and the federal government. Some of this seems to lead right to the door of the Prime Minister. It was the premier and the Prime Minister having friendly chats together making the deal.

Even with the present minister, we have all sorts of insinuations and suggestions, especially coming out of Saskatchewan, that there was some understanding between the federal government and the provincial government. In fact, in a very disturbing speech made by the president of the Saskatchewan Power Corporation, Mr. George Hill, last Friday he stated:

In January, 1990, Dr. Good (one of the same civil servants) implored me not to insist on putting a time limit on when the Panel had to report. He no doubt wanted it to look like they had all kinds of independence. He assured me that he would have control over the Panel, through the Chairman, who would be an employee of the Federal Environmental Review Office. It must be understood that this office, known as FERO, for Federal Environmental Review Office, is not independent from the rest of the Federal Environmental Department. The head of FERO reports to Dr. Good, Dr. Good had spun his web to include all these people. He assured me that he was in control and he would see that they acted expeditiously and report in short order, because after all, this project had already been reviewed twice.

That is a statement by the president of the Saskatchewan Power Corporation saying that he had the assurance of the deputy minister of the federal Department of the

Environment that he was able to control the panel and the workings of the panel.

That is a very serious charge. I hope that the Minister of the Environment will stand on his feet some time today and explain what Mr. Hill was talking about. Surely he can give us the assurance that the environmental review panel is indeed independent and not controlled by his department.

We must also really wonder about the motivations of the Saskatchewan government.
