Point of Order

I would ask you, Madam Speaker-

I think tomorrow will be another day for Question Period. I would like us to proceed with the business before the House.

Some hon. members: Point of order.

I will listen to the hon. member for Churchill, but I do hope that he will keep his voice down.

Mr. Rod Murphy (Churchill): Madam Speaker, I apologize for shouting, but you had cut off debate. I think this is a very important item and I had stood quietly three times previously on it. In your last intervention you said that there was no way of knowing what was coming up today in debate.
