I.O.O.F. GRAND LODGE

Elect a London Man as Grand Warden
—Other Officers chosen—Patriarchs
Militant Elect a New Council.

Hamilton, Aug. 9.—This morning the I. O. O. F. Grand Lodge got down business in short order, and several matters were disposed of before noon. The roll call showed an attendance of 850 grand officers and representatives. Grand Master McLurg announced that by the past grand vote of the subordinate lodges, Rep. O. L. Lewis, of Chatham, was elected by acclamation to be grand master; Rep. C. C. Lyman, Brockville, to be deputy grand master; J. B. King, grand secretary; W. J. McCormick, grand treasurer; P. G. Chase, Packard, of Stratford, auditor (by acclamation); Past Grand Sir Dr. C. L. Campbell, London, as a member of the board of Oddfellows' Home for three years.

The vote for grand warden, which practically entitles that officer to the position of grand master, resulted in the election of Rep. R. K. Cowan, of London.

The report of the special committee on mileage and per diem recommended that representatives and others serving on committees be allowed mileage at the rate of 5 cents per mile one way of the usual traveled route, and \$2 per diem.

INTERESTING
TESTIMONY

Given by the Late Joseph Sifton's Fiance.

Mary McFarlane Tells of Morden's Warning.

She Urged Joseph Not to Go With the Prisoners to the Barn on the Fatal Morning—The Wedding Presents From Her Intended Husband—A Missing Wad of Money—The New Will.

Thursday Afternoon.

On the resumption of the Sifton examination at 2:15 p.m. Mary McFarlane took the stand. Up to June 30 last she was employed at Gerald Sifton's.
