All except the Harris Abattoir Company and the Swift Canadian Company, Limited, of Toronto, were refused licenses at the time of their application because their establishments did not conform to the requirements of the law as laid down in section 4 of the regulations passed on November 17, 1917.

3. The report of the commission of which Mr. George F. Henderson, K.C., of Ottawa, was chairman does not deal explicitly with the points covered by questions 3 and 4, but statements in the report as to the proportion of stock held by Sir Joseph Flavelle in the Wm. Davies Company, Ltd., and as to the proportion of stock held by the Wm. Davies Company, Ltd., in the Harris Abattoir Company, would indicate that the interests of Sir Joseph Flavelle in the Harris Abattoir Company were on May 12, 1917, approximately twenty per cent. The report in question has been tabled.

2. (a) Salary as Law Secretary, \$5,000; (b) additional salary as Examiner as aforesaid, \$2,000; (c) General Returning Officer, nil.
