1st September, 1946 (consolidation of salary and cost of living bonus)-\$1,644-\$1,764,\$1,884-\$2,004-\$2,124.

1st October, 1947-\$1,620-\$1,740-\$1,860-\$1,980-\$2,100-\$2,160.

The adjustment effective 1st October, 1947, provided that employees in receipt of salary at the rates of \$1,644-\$1,764-\$1,884 would receive an immediate increase of \$216 per annum, those at \$2,004, an immediate increase of \$156 per annum and those at \$2,124 an immediate increase of \$36 per annum.

MARSHLANDS

RECLAMATION AND DEVELOPMENT-ASSISTANCE TO MARITIME PROVINCES

Hon. ERNEST BERTRAND (for the Minister of Agriculture) moved that the house go into committee at the next sitting to consider the following resolution:

That it is expedient to present a bill to assist the provinces of Nova Scotia, New Brunswick and Prince Edward Island in the reclamation and development of marshlands in the said provinces by the construction and reconstruction of works tion of works necessary therefor and the pur-chase of required machinery and equipment. Works may be undertaken only on the recommendation of an advisory committee to be est-ablished under the act and upon terms and conditions agreed upon with the province con-cerned prior to the first day of May, nineteen hundred and fifty-five. The Minister of Agri-culture is empowered to appoint necessary temporary officers and employees to be paid out of the consolidated revenue fund with provision also for the payment of expenses of members of the advisory committees.
