**Mr. Benidickson:** That is quite right. But we had a broad statement that there were five reductions and four increases. I just wanted to make sure that my hon. friend and I are not comparing oranges with grapefruit.

**Mr. Fleming (Eglinton):** Would it not be better to deal with these items as we come to them. I gave the numbers of each of those items. Would it not simplify the procedure if we dealt with each of these items when we come to them?

**Mr. McIlraith:** The point can be cleared up. There was a little bit of confusion as to the numbers which the minister was calling out at this point. He was interrupted and he turned to clarify the numbers. If

he would again just clarify the numbers that were reductions and the numbers that were increases I think we could dispose of the point.

**Mr. Fleming (Eglinton):** I gave the correct numbers, Mr. Chairman. I will go over them again.

**Mr. McIlraith:** I would ask the minister to do that.

**Mr. Fleming (Eglinton):** The increases are in items 378, 380,—there are two parts there; just take it as 380—381a, 382 (5). Those are the four increases. The five decreases are these: 380, 380a, 382 (7), 384, and 392a (2).

**Mr. Benidickson:** And which would not show on our papers?

**Mr. Fleming (Eglinton):** That is right.

Item agreed to.

**Mr. Fleming (Eglinton):** The tariff board recommended in their item No. 4b that all wide-flange beams more than 10 inches in depth be duty free under the British preferential tariff and dutiable at \$5 per ton under the most-favoured-nation tariff.
