ELEVATOR CONSTRUCTORS' STRIKE—SUGGESTED FEDERAL PARTICIPATION IN INDUSTRIAL INQUIRY COMMISSION

Mr. James A. McGrath (St. John's East): Mr. Speaker, may I direct a supplementary question to the Minister of Labour. As the Liberal government of Nova Scotia proposes, with the other provinces, to set up a provincial industrial disputes commission to get around the niceties of the constitution, is the minister prepared to use his good offices and the facilities at his disposal, to assist in the setting up of the commission and to work closely with the provinces in order to bring about the settlement of this costly dispute?

Hon. John C. Munro (Minister of Labour): Mr. Speaker, aside from the question of whether the setting up of a commission would rapidly settle the dispute, which is a very open question in itself, I have already said that, because of the serious economic implications of this strike, I and the government would be prepared to assist in any possible way but that we must have a basis upon which to act and that must come from the provinces.

OIL—EASTERN CANADA SUPPLY—FEASIBILITY STUDY ON PIPELINE EXTENSION—ASSURANCE OF SUPPLY BY UNITED STATES

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): Mr. Speaker, may I direct a question to the Minister of Energy, Mines and Resources arising out of the announcement that there is to be a substantial increase in the price of Venezuelan crude oil. As the area east of the Ottawa River is largely dependent on this source of supply, I want to ask the minister whether his department or the National Energy Board have completed the feasibility study on extension of the interprovincial pipeline, which his predecessor announced was under way, and whether the findings of that study will be made available to members of the House?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): No, Mr. Speaker. I remind the hon. member that the price differential between Montreal and western oil is between 90 cents and \$1. Even if the Venezuela price goes up, it will still be substantially below the Canadian supplier.

Mr. Douglas: Mr. Speaker, I asked whether the study is under way or is completed. In view of the discussions that have been going on between the minister and his counterpart in the United States government regarding contingency plans to ensure security of supply for eastern Canada in the event of a crisis, can the minister tell the House whether he has received any assurance from the United States government regarding security of supplies for eastern Canada apart from the promise they would put forth their best endeavours to see that oil would be made available to eastern Canada?

Mr. Macdonald (Rosedale): Mr. Speaker, as I have told the House several times, there is no agreement between the two governments at the moment. Officials will be meeting to negotiate further possible terms, but at the moment there is no formal arrangement between the two governments.
