That Bill C-155 be amended by adding immediately after line 6 at page 35 the following:

"60(1) Following the completion of any review or study carried out under section 59, the Minister, within 120 days, shall prepare a detailed and comprehensive response to such review or study, including the Minister's acceptance or rejection of each conclusion and recommendation contained in any review or study and the reasons therefore.

60(2) The Minister shall cause a copy of his response referred to in subsection (1) to be laid before Parliament on any of the first fifteen days that either House of Parliament sits after the preparation of that response and such response shall stand permanently referred to any Committee of Parliament established for the purpose of reviewing matters relating to transportation."

Madam Speaker: Order. Has the Hon. Member finished reading the amendment?

Mr. Taylor: In any event, Madam Speaker, I ask that you seek the unanimous consent of the House to waive notice that the motion as read be placed on the Order Paper for debate during the consideration of report stage of Bill C-155, an Act to facilitate the transportation, shipping and handling of western grain, and to amend certain Acts in consequence thereof.
