decrease of \$232 million U.S., or roughly \$300 million in Canadian dollars.

Can the Minister tell us what happened to those loans? Were they transferred to other Canadian Commercial Bank branches?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, I would like to point out that the first order released on the Canadian Commercial Bank, its agency and its subsidiary bank in California from the regulatory authorities, came in February, 1984.

I am not sure where I was then precisely, but I know I was not here. I think the question around the transfer of assets could be addressed to some of the Hon. Member's former colleagues since the activity in those agencies started long before my time.

SYDNEY STEEL CORPORATION—GOVERNMENT FUNDING

that Canadian railways, CN especially, will be ordering their rail lines from Sydney Steel?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, as the Hon. Member undoubtedly knows, I met with Premier Buchanan yesterday. Among other things, we discussed the situation at Sysco. We received the updated Hatch report concerning Sysco. We reviewed its recommendations and felt that they were quite positive. In the context of those recommendations, we have agreed in principle to come to an agreement which will hopefully affect the recommendations in the Hatch report, and an announcement should be made within a few weeks.

MODERNIZATION OF PLANT

Mr. Rod Murphy (Churchill): Mr. Speaker, my supplementary question is directed to the same Minister. Will a commitment be made by the Government to complete funding of the Phase II modernization of that plant, or will we have more years of delay and indecision as we had under the Liberals?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, obviously the Hon. Member was concentrating on his supplementary question without listening to what I said. When he has an opportunity to read *Hansard*, I think he will see that a very definitive, positive answer was given.

DESIGNATION OF AREAS IN ALBERTA UNDER FEDERAL DEVELOPMENT PROGRAMS

We have the entire tier system under review. He will be pleased to know that under the existing ERDA program a subagreement affecting his area will likely be entered into very soon, and I think the area residents will find it very beneficial.
