The bank clearings for the week end-

Furness steamship Rappahannock, for
London, from this port, took away a car
go valued at \$33,238. She had on board
29,605 bushels wheat.

Coal steamer Cape Breton arrived this
noon from Sydney, C. B., with a cargo of
coal. The steamer had a very rough pas-
sage, and is considerably tied up.

Owing to derailments on the C. P. R.
yesterday, the Montreal and Fredericton
trains were late in arriving. I. C. E. trains
were also somewhat delayed.

John Burley has been elected chaplain
of the St. John County Loyal Orange
Lodge instead of John Rusik as announced
yesterday.

Olaf Holmberg, a Swedish sailor, was
the only prisoner in the police court this
morning. He was charged with drunken-
ness and was allowed to go on suspended
sentence.

C. P. R. steamship Lake Erie, now on
her way to Liverpool, from this port, took
away a cargo valued as follows:—Canadian
goods \$213,156, foreign goods \$132,441.
Total \$345,597. Among her cargo were
95,804 bushels wheat.

Steamer Calvin Austin, Captain Pike,
called this morning with a large freight
for Boston and Maine ports. She took
away 305 cases gum chicle, valued at about
\$15,000, for Curtis & Son, of Portland,
Maine. C. S. Stevens is their agent here.

It will be remembered that the Salva-
tion Army announced a special welcome
home meeting to take place last Thursday
in Charlotte street barracks but owing to
the Bermuda boat being late in arrival
this meeting was postponed until tonight.

OBITUARY

William Griffiths

The death occurred quite suddenly this
morning of William Griffiths, an engineer
in the street department, at the home
of his daughter, Mrs. S. A. Morrell, 223
Main street. Mr. Griffiths had only been
ill a short time and it was not thought
his condition was serious until he took a
turn for the worse yesterday afternoon
and Dr. Roberts was called in. Again,
last night, the doctor had to be summoned
as the patient was much weaker, and this
morning he passed away. Heart trouble
is said to be the cause of death. Mr. Grif-
fiths was 74 years of age. He was very
well known about the city and was highly
regarded by all. He acted as an engineer
in No. 1 Wellington company of the fire
department for 16 years, leaving there a
few years ago to assume the position of
engineer of the city stone crusher.
He is survived by three sons, all resid-
ing in Boston, and by three daughters—
Mrs. S. A. Morrell, Main street; Mrs. Al-
fred Morrell, Bellisle, and Mrs. Seely, re-
siding somewhere up north.
The arrangements for the funeral have
not yet been completed.

HOUSE BURNED AT
HAMPTON VILLAGEJames Logan's Cottage De-
stroyed This Morning—Pres-
byterian Church Was Slightly
Damaged.

HAMPTON, N. B. Feb. 6.—(Special).—
About half past seven this morning the
prolonged whistle of the village mill in-
dicated that some disaster had occurred
or was in progress and in a few minutes
crowds of people hastened over the road
between the station and village to dis-
cover smoke and flames issuing from
the residence of James Logan, situated
next to the Presbyterian church.

The Hampton Village fire apparatus was
speedily on hand and neighbors assisted
in removing the furniture and subduing the
flames, which had full possession of the
story, and a half cottage, the long ell and
wood house in the rear, and seriously
threatened the Presbyterian church. The
furniture was removed, but the furnace
and an acetylene gas plant in the cellar
were destroyed with the premises.

When it became evident that the main
building was deemed the chief efforts of
the firemen and workers were centred
upon saving the church building and with
such success that the damage was confined
to one corner and that of not much ex-
tent.

The origin of the fire is supposed to be
a defect in the kitchen due, but whatever
the source a snug and slightly homestead
now lies in ruins, and a respected family
is for the time rendered homeless. The
amount of the loss cannot be obtained at
present but it is understood Logan had
\$1,000 insurance and the damage to the
church is covered by \$1500 insurance in
the office of Jarvis & Whittaker.

THE FISH MARKET

As a result of unfavorable weather con-
ditions receipts in fresh fish have been un-
usually light during the past few days.
Clam digging has been almost an impos-
sibility and the same may be said of lob-
ster fishing.

The retail market will be fairly well
supplied but those desirous of the best
quality from which to select would do well
to be on hand early.
Fish dealers suggest that intending pur-
chasers place their orders this evening
in order to ensure prompt Friday morn-
ing deliveries. Retail figures rule as fol-
lows:—Cod 6c per lb., cod steak 10c,
halibut 15c, smelt 10c to 12c, flounders
8c, haddock 6c, salmon 12 to 20c, bloat-
ers 25c per doz., kippers, 30c, haddock
8c per lb., dried cod 6c, boned
cod 12c, oysters 75c to \$1.00 per quart;
clams 15c, scallops 60c, lobsters 15 to
40c each.
