Bounty on Hemp not intended for fale, not to be claimed after 30th Sept. 1804.

of Hemp, for or in relpect of any Hemp for which the faid fam of forty pounds per ton shall be paid under the powers hereby given; nor shall any bounty or premium be paid or payable for or in respect of any Hemp not intended for sale to some one of the Commissioners acting in virtue of the powers hereby given, which shall not be claimed on or before the thirtieth day of September next, under proper and sufficient documents to be on or before that day presented to the person or persons duly empowered or authorized to allow or pay the same, any former law to the contrary notwithstanding. Provided nevertheless, That before the said Commissioners to be appointed in virtue of this Act, or any of them, shall, under the authority hereby given, purchase any Hemp from any person or persons whomsoever, such Commissioners and each of them, are and is hereby authorized and required to administer to the person or persons offering any such Hemp for sale, the following Oath:

Oath.

"I A. B. do swear, that the Hemp which I have this day offered for sale to C. a Commissioner oppointed by his Excellency the Lieutenant Governor for the purchase of Hemp, and every part thereof, was raised within the Province of Upper Canada, by me (or by E. or F.) and that no bounty or premium has been paid or claimed for any part of such Hemp, by any person or persons whomsoever, save and except what is included in the sum or price, for which I have offered to sell such Hemp to the said Commissioner."

Penalty for corruptly for wearing. And if any person or persons shall, in taking such Qath, wilfully or corruptly softweet him, her or themselves, such person and persons shall incur all the paint and penalties which by law persons are subject or liable to, for wilful or corrupt perjury in any case whatsoever.

Commissioners may demand bounties, &c.

IV. And be it further Enacted by the Authority aforefaid, That it shall and may be lawful to and for each and every of the Commillioners afting in virtue of the powers hereby given, to demand and receive of and from the person or persons who now is or are authorized or empowered to allow and pay the aforefaid premiums or bounties, under the faid Proclamation and Proclamations heretofore issued, the sum of tenpounds per ton for every ton which such Commissioners shall, in virtue of the authority hereby confered, purchase; and every such sum of ten pounds for each and every ton to purchased by the said Commissioners, or any of them, shall be applied to and for the purpoles of this AA, over and beyond the faid fum of one thouland pounds herein before granted: And luch person or persons so now empowered to allow and pay fuch bountles or premiums, is and are hereby authorized to pay such Commissioners, or any or either of them, the faid fum of ten pounds per ton on fuch Hemp as aforefaid, until fuch part of the funds now in their hands, or remaining in the hands of the Receiver General, unapplied and applicable to fuch bounties or premiums, shall, by fuch payments to the faid Commissioners, and to other persons entitled to such bounties or premiums, be wholly exhausted.

Hemp to be exported to England and there fold.

W. And be it further Enacted by the Authority aforefaid, That it shall and may be lawful to and for such Commissioners so to be appointed under this Act as aforesaid, or the major part of them, in such manner and by such ways and means, as to them or the major part of them, at any time shall seem meet, to cause and procure such themp as thall be purchased according to the provisions of this Act, to be exported and carried beyond sea into that part of Great Britain called England, and there to

be exposed for fale, and fold for fuch price or prices, sum or sums of money as shalland may be obtained for the same; and such sum or sums of money obtained by such

British bounties to be obtained.

fale or fales, together with such bounties or premiums as shall or can be obtained under any Act or Acts of the British Parliament, or of the Parliament of the United Kingdom, on any such Hemp as aforefaid, after deducting all necessary charges, to pay to the Receiver General as applicable and to be applied to the public uses of this Province, and the support of the Government thereof.

VI. And be it further Enacted by the Authority aforefaid, That the monies hereby granted to his Majeffy, thall be paid by the Receiver General, in difcharge of Juch warrant or warrants as shall for the purposes herein before let forth, be from time to time illued by the Governor, Lieutenant Governor, or Person Administering the Government of this Province, and not otherwise. And the said Receiver General shall account to his Majeffy, his heirs and successors, for the same, through the Lords Commissioners of his Majeffy's Treasury for the time being, in such manner and form as his Majeffy, his heirs and successors, shall be graciously pleased to
