MacDonald to the effect that the Kraft Company, which operates in Canada as well as in the United States exercises a control on the exports and sales of Canadian cheddar to the United States?

Mr. Macdonald: The director informs me that press reports of Mr. MacDonald's allegations indicate that the situation relates to import quotas imposed under United States legislation and therefore would not appear to be a matter coming within the purview

### R.C.M.P. AUXILIARY POLICE

Question No. 932-Mr. Barnett:

1. Are auxiliary police being enrolled with the R.C.M.P. and, if so, in what provinces is this being done and under what legislative or governmental authority?

2. What are the duties to be performed by auxiliary police and what course of training do they

receive?

3. What remuneration or emoluments do auxiliary police receive?

Mr. Favreau: 1. Auxiliary police have been enrolled with the R.C.M. Police in the provinces of British Columbia, New Brunswick and Prince Edward Island. This has been done by provincial order in council which is authorized under the provincial civil defence act.

2. The duties of these auxiliary police are to assist the R.C.M. Police in effectively discharging its provincial duties in time of national emergency or natural disaster. Their training consists of instruction in the following subjects, which is carried out by the R.C.M. Police: (a) criminal law; (b) crowd control; (c) discipline; (d) emergency planning; (e) first aid; (f) foot drill; (g) general police work; (h) small arms training.
