RESTRICTIONS ON EXPORTS TO CHINA

Question No. 1,111-Mr. Mather:

Are Canadian subsidiaries of US manufacturers of agricultural and transport machinery restricted in any way from exporting such equipment to China?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Agricultural and civil transport machinery may be exported from Canada to the People's Republic of China under the authority of an export permit issued under the Export and Import Permits Act. Permits are generally granted to any resident of Canada applying to export such goods. Goods of United States origin require the prior authorization of the United States Government; i.e., general license, validated export license, or other authorization under a provision of U.S. Export Control Regulations.
