ment precisely to discuss with them the latter's projects, which could not have been revealed at the time the conference was held, as the federal-provincial consultations were still in progress. I am sure the hon. member cannot feel that, in a field such as young people's activities and student employment, we can neglect the position of the provinces which is an aspect of paramount importance in such an area.

Mr. MacDonald (Egmont): Since the Secretary of State has indicated the government had no plans and therefore could not discuss them at this important meeting, did the government give consideration to the possibility of asking for a further delay or of indicating in any way its reasons for not participating in this conference, apart from the reason advanced by the minister that there had not been direct federal-provincial consultation, because it is the understanding, I think, that all provinces had expressed an interest in participating in this conference?

[Translation]

Mr. Pelletier: Mr. Speaker. I have never said that the government did not have any plans. I said the government's projects were ready; the Acting Prime Minister said so last Thursday; he gave general indications to the effect that the program was bigger and better, I believe. It will be better organized and more efficient than last year's. But what I said, and repeat here, is that considerations of time, that is the need to consult the provinces, have kept us from meeting the first date set for the conference, and in another connection, that the possibilities of consultation offered by that conference did not involve provincial governments but the delegates of private organizations, which would certainly not have been useless. But that is not the type of consultations we seek. The delay in announcing a policy is due to the necessity of holding consultations with the provincial authorities.

SUMMER EMPLOYMENT PROGRAM FOR STUDENTS-CONSULTATION WITH PROVINCES
