# NFB MOTION PICTURE PRODUCTIONS—SPONSORED FILM PROGRAM

## Question No. 3,562-Mr. Friesen:

1. Does the government expect to implement the statement of intention by the Secretary of State on July 4, 1972, that "The National Film Board will no longer be the exclusive recipient of Government commissions; it will now have to compete with private producers for all film contracts awarded by a federal department or agency" and, if so, on what date?

2. In 1973-74, what was the total number of original motion pictures (a) produced by NFB for either their own programmes or for departments or agencies (b) contracted out by NFB to private Canadian producers?

Miss Coline Campbell (Parliamentary Secretary to Secretary of State): 1. The government has already given effect to its policy of contracting out an increasing share of its sponsored films requirement to the private sector, through the National Film Board. The record speaks for itself: Prior to 1972 the private sector received a maximum 8 per cent of the total NFB sponsored film program. This was worth approximately \$144,000 during fiscal year 1970-71. By the end of fiscal year 1974-75, the value of contracts to the private sector rose from \$144,000 to approximately \$1.6 million representing about 50 per cent of the total sponsored film program. In other words, during this period, the share to the private sector increased from 8 per cent to 50 per cent. The extent to which the NFB will compete with the private sector is the subject of current review and consultation with film industry representatives.

### [Translation]

Mr. J.-J. Blais (Parliamentary Secretary to President of Privy Council): Mr. Speaker, 1. The Prime Minister's Office has never established any formal economic advisory group. Dr. Albert Breton has acted as an economic consultant to the Principal Secretary, and on four occasions in late 1974 and early 1975 individuals in the economic field practising outside of the government's employ met with Dr. Breton for discussions with the Principal Secretary of Their views on events of economic concern to the private sector.

2. Four meetings were held and expenses paid in connection for these meetings were \$1,962.29. No remuneration was paid, but each received an honorarium in the amount of \$100 for each meeting.

3. No retainer has existed in respect to these particular meetings, but Mr. Breton has been retained at \$200 per diem (as required) as an economic consultant in the Prime Minister's Office since September 16, 1974 to date.
