DENIAL OF ACCESS TO LABOUR LEADERS OCCUPYING CORPORATION OFFICES

Mr. Dave Dingwall (Cape Breton—East Richmond): Mr. Speaker, my question is directed to the Acting Minister of Regional Industrial Expansion and concerns the attitude and actions of the Chief Executive Officer of the Cape Breton Development Corporation. Could the Minister explain to the House the rationale and reasoning behind the Chief Executive Officer prohibiting the Leader of the Official Opposition in the Province of Nova Scotia from entering a federal building in order to speak with seven labour leaders to try to resolve the matter which the Minister knows can become a very serious matter at the Cape Breton Development Corporation? Why is the Minister allowing the Chief Executive Officer to prohibit duly elected personnel from speaking with these labour leaders?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, I am sure the Hon. Member is aware that union elections are taking place today. I do not think it would be proper for politicians to intervene in the election process or to be seen as interfering. I indicated to the House yesterday that I thought it was inappropriate and that it would seem to me to be right and proper to allow the elections to be finished. There is a task force mechanism in place that can be used, I hope, to resolve the problem, and if it is necessary to supplement or complement that process, we will take that under consideration.

MINISTER'S POSITION

Mr. Dave Dingwall (Cape Breton—East Richmond): Mr. Speaker, can I take it from the Minister that, pending the outcome of those elections, he would then give a directive to the president of the corporation, as well as send down a special envoy to meet with the labour leaders, in order to address in a very substantive way the rightful concerns over high unemployment and the future of the Cape Breton Development Corporation, or is the Minister saying that we will have to wait until there is a situation like the one in Edmonton with people on the streets?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, I did not indicate that I would give the Chief Executive Officer a directive. I did indicate, as the Hon. Member knows, that there is a task force in place that is equipped to resolve these kinds of issues, and I did indicate that if it was necessary to supplement that task force I would consider doing so. I think the important thing is to get the elections over with so that there is a cooling off period. Then we can take a look at it.

CANADA-UNITED STATES NEGOTIATIONS

REFUGEES

DISTRIBUTION OF LETTER TO POSSIBLE REFUGEE STATUS

Mr. Sergio Marchi (York West): Mr. Speaker, my question is for the Minister of Employment and Immigration. On June 9 the Minister told the House that letters inviting refugee claims had not been sent to alleged murderers and drug traffickers. Today we learned that the Director of Refugee Affairs told the Kitchener-Waterloo Record that in fact thousands of letters to such individuals were sent. Why did the Minister deny in the House last Monday that such a letter existed? Why were such letters of invitation sent to those individuals? Who is in control of her Immigration Department?
