Hon. R. B. HANSON (Leader of the Opposition): Mr. Speaker, as the house is already aware, a motion has been passed for the adjournment of this house at six o'clock on Wednesday for a substantial period. I understand the date of the adjournment was fixed on the conditional understanding that possibly the budget would be brought down the first of the coming week. Mr. M. J. COLDWELL (Rosetown-Biggar): Mr. Speaker, may I interject that until five minutes ago I had no knowledge that this suggestion was going to be made. I should like it to be clearly understood that, so far as our group is concerned, we are not asking that this be done; indeed, we are opposed to it.
